

Glossary of Terms

When we talk about Children's Services we use terms that have a specific meaning. This glossary provides a definition for these key terms. These terms are used to describe the:

- type of children's service
- type of provider management
- owner of the asset the building from which the service operates
- owner of the land on which the asset is located
- other key terms used in Every Child, Our Future: Policy Issues and Options Paper

Type of children's service

There are many different types of children's education and care services. When we talk about early years or children's services we mean the services that provide education, learning and development experiences from birth to the commencement of primary school years available to families in the City of Port Phillip. These services support the health and wellbeing all children and families. In Every Child, Our Future: Policy Issues and Options Paper the use of the term, children's services includes the following services:

- childcare, including:
 - long day care
 - family day care
 - occasional care
- kindergarten including
 - sessional kindergarten
 - extended hours kindergarten
- play groups, including:
 - supported play groups
 - community play groups
- toy libraries

This is defined as the following:

Type of management

Different types of providers may manage children's education and care services. When we talk about the type of management we mean the type of provider operating the service not how the service is managed.















We have used the Australia Children's and Quality Care Authority classifications (in the Australian Bureau of Statistics' National Early Childhood Education and Care Collection) to identify the type of provider manager. The provider manager is the legal or social entity responsible for managing the delivery of an early childhood education and care service. These classifications apply to childcare and kindergarten. All play groups and toy libraries are not for profit entities.

Note:

- It is not mandatory for services to report provider management type to ACECQA and therefore data may not be current.
- The ACECQA category of Private not for profit community managed includes community managed centres operating in Council assets and community managed centres operating in other assets.

Other key terms

Early years services	The services that provide education, learning and development experiences from birth to the commencement of primary school years available to families in the City of Port Phillip. These services support the health and wellbeing all children and families.
Municipal Early Years Plans	Municipal Early Years Plans (MEYPs) foster a whole-of-community, whole-of-system approach to building community strength and addressing the underlying causes of inequity and vulnerability of children and families. MYEPs are place-based with a focus on prevention, equity, health and long-term social and educational outcomes for children
Early Years Facility Framework	The plan to ensure council assets enable the children's services policy and the municipal early years plan to be delivered. This will be developed after the policy is endorsed.
Property Policy	Port Phillip's property policy will provide a framework for decision making for the strategic management of the portfolio, for repurposing land and buildings, for land acquisitions and sales, and for leasing or licensing facilities to commercial operators and community based organisations. Council is currently consulting on the principles of this policy which include: equity - particularly equitable distribution of council resources maximising community benefits, particularly benefits aligned with the Council plan being fit for purpose, including the condition and capacity of the building
Implementation plan	The implementation is a process that turns strategies and plans into actions in order to accomplish council's vision for children's services. The implementation plan will be developed after the children's services policy has been adopted and will be developed in consultation with key stakeholders.
National competition policy	Federal government policy that all local governments (and other government agencies must follow). This policy was introduced in 1995 to ensure that activities undertaken by government compete fairly in the market. This requirement is based on the principle that competitive markets generally best serve the interests of the community. National competition policy only applies to Council-managed significant businesses, not subsidies to community managed providers. Any Council-managed significant business is required to demonstrate that any advantage (eg subsidies) are in the public interest or move to a fully cost-reflective model.
Full cost recovery	An analysis of the net cost of delivering the service or good that accounts full cost of providing the service or maintaining an asset.
